

# LOS ANGELES MANUAL ARTS HIGH WINS; VISALIA SECOND; TWO WORLD MARKS SET

House of Riverside Is Star of Meet; Scores 11 Points and Breaks World Record; Long Beach Man Sets New Mark in High Hurdles

Five world and coast interscholastic track records were broken yesterday at the first annual track and field meet of the California Interscholastic Federation, held at the county fairgrounds. One hundred athletes, representing eighteen high schools competed.

The results: Los Angeles, Manual Arts, 10; Visalia, 18; Long Beach, 14; Santa Rosa, 12; Riverside, 11; Santa Paula, 10; San Jose, 5; Los Angeles Poly, 7; Sacramento, 4; Easter, 4; Pasadena, 4; Calinga, 6; Santa Ana, 3; Hemet, 2; Glendale, 2; Bakersfield, 2; Palo Alto, 1; Hanford, 1; San Mateo, 1; Berkeley, 0.

House of Riverside broke the world's interscholastic record in the 220 yard hurdles, covering the distance in 22 4-4 seconds. The former record is 24 4-4 seconds. The other world's record was broken by E. Thompson of Long Beach in the 120 hurdles. Thompson ran the last barrier race in 15 1-4 seconds, the former record standing at 15 2-5 seconds.

Coast interscholastic records fell in the 440 yard run, 220 yard dash and 880 yard run. Conn, the only entry from Pasadena, ran the 440 in 50 seconds flat, against 55 2-5 seconds, the former record.

In the 220 yard event, Work of Long Beach, lowered the coast high school record by one-fifth of a second, making the distance in 22 seconds flat. The former record was 22 1-5 seconds.

Blankenship of Visalia, set a new and official mark for the 880 yard run, covering the quarter in 1 minute 29 4-5 seconds. During a trial meet at Stanford last year, this distance was run in 1 minute, 28 1-5 seconds, but this time was never considered as an official record.

## Speed Due to Track

The breaking of records and the general speed shown in the various track events was due almost entirely to the fact that the county track was in excellent condition. In addition to this, the pick of California high school talent was competing. A slight wind behind sprinters in several of the events, also figured slightly in the running time, although not enough to figure relatively in the result.

Athletes from southern California were the fastest by far and weather conditions were favorable to them. The southern division scored more points than the other three divisions of the state combined. This was due to a larger entry and by the fact that the high schools of southern California have developed a great many star track men.

Only one or two northern schools were represented in the meet and their showing was not to be compared with that of athletes from the south.

Visalia was the only real contender against Manual Arts of Los Angeles. For the first four or five events Visalia led the meet, but as the program wore on, Manual Arts gradually went into the lead. The victory in the relay, the final track event, coupled with places in several of the field events, put Manual Arts out in the front beyond all chances of defeat.

## House the Star

House of Riverside was the individual star of the meet, scoring eleven points for his school. This duplicates his feat of two weeks ago in a "prep" meet in the south. House took first place in the 220 yard hurdles, second in the 120 hurdles and second in the broad jump.

Blankenship was the second big point winner of the meet and so him is credited ten of Visalia's eighteen points. Blankenship won first place in the mile and half mile.

## Becker Disqualified

Bakersfield was put out of the running by the disqualification of Becker, its star performer. Referee Bob Weaver of Los Angeles declared the Bakersfield man ineligible yesterday morning before the start of the preliminary races.

This decision was made on the grounds that Becker had for two years previous to coming to Bakersfield, competed under the colors of Occidental college. For two years Becker was a member of the Occidental "prep" school and while there participated in a number of meets, winning points for his college.

Becker's case will be taken up by the Central section officials and should investigative substantiate the action of Weaver, Becker will be asked to return medals won in the Central section meet here on April 18 and all points won by him will be thrown out. Other winners of the events in which Becker participated will gain points by Becker's removal and in all probability this will cost Bakersfield the Central section meet.

# Preliminary Events to Be Run Off at 10 o'Clock This Morning; Two Trophies and Individual Medals for Winners in Meet

More than a hundred athletes, the pick of California high school talent, will compete for the state interscholastic championship at the county fair grounds track today. Elimination trials in the 100 yard dash, 120 and 220 yard hurdles, 220 dash and running broad jump will be held at 10 o'clock this morning in order to expedite the events of the afternoon.

Thirteen regular and two exhibition events are included in the championship list. The exhibition events are the javelin and the hammer throw.

Points are to be given for the first four places: five for first, three for second, two for third, and one for fourth. Gold, silver and bronze medals and ribbons are to be awarded to the individual winners. A perpetual trophy will be given to the winner of the meet and a perpetual trophy to the winner of the relay. The Fresno Republican is giving the latter prize.

Meredith House, an all-round star from Riverside, is expected to score a number of points for his school. House

has entered the two hurdles and the board jump. At present, he holds the interscholastic record for both hurdles.

Frank Walters of Eater, interscholastic hammer thrower, is conceded this event as he is in better condition than when he scored a record mark at Stanford last year. Walters will also take part in the 12-pound hammer throw and is looked on as a contender in this event.

Fresno high school will have its largest rooting squad of the year out today in an attempt to get the Fresno's representatives in the winning list.

# STATE MEET TO COME SATURDAY

of Manual or Visalia Picked to  
Returned Winner.

## Northerners Fast in the Track Events.

## Southerners Have Edge in Field.

The California State interscholastic track and field meet, the greatest prep meet of the year, will be staged at Fresno Saturday. In this throng of cream of prep athletes of the whole State will be represented.

This track meet is the first of its kind to be held under the auspices of the California Interscholastic Federation. It takes the place of the meets which were formerly held at the University of California and Stanford University.

The best of the athletes of Southern California have been entered. Among those coming in first or second in the Southern California meet held last Saturday are to be the ones sent to Fresno to represent the south.

Of the individual schools entered Visalia High of the central section and Manual Arts High of the southern section are the two schools to fight it out for the State championship.

Visalia High's strong points are the sprints and the distance runs, while Manual Arts looks to be the best of the two in the hurdles and weight events.

According to the dope from previous meets, the southern section of the State should win the meet, with the central section a close second. The northern section of the State is not expected to be a contender for the championship of the State.

### FAST SPRINTER.

In the 100-yard dash Visalia of the central section is expected to take first. Their best sprinter has done 10:1-5s, consistently this year and has covered the distance in 10 seconds flat. Wark of Long Beach and Warren Lamport of Manual are expected to give him a rub for first honors.

Visalia looms up strong in the 220-yard dash, also. Their runner has a record of 22:1-5s. The best made in the south was in the Southern California track meet, when Wark of Long Beach was timed at 22:4-5s. But the record made by Wark last Saturday would have been better had the race been staged on a good track. Track officials claimed that had the track been in good condition the race would have been at least two-fifths of a second faster. The same applies to the 100-yard dash and all other races.

In the 440-yard dash the south has the edge on the dope. The best time made in the north was in the Central California championship meet, when the distance was covered in 52:1-5s. Conn of Pasadena has a record of 51:1-5s, and should win this event. Ray Hughes of Manual Arts is also expected to be in the point winning in this event.

### GEORGE UP AGAINST IT.

The 550-yard run and the mile run both go to the central section. Visalia is exceptionally strong in these events and is expected to win both. Noel George of Poly will have to go his best to be in the running. One of the Visalia runners has a record of 1m. 53:3-5s. for the half mile, which is by far the best time made in the State. Reid Crippen will also have to compete with a mile runner that has a record of 4m. 36s, and who was not forced when he made that time.

The south has a good hold on the hurdle events. Thompson and House in the high hurdle race have both done better than the best in the north; 16:3-5s. will win in any meet in the north, while both of these boys have done better than that. Thompson has run the high stick race in 16 seconds flat, and House of Riverside is just as good.

Manual Arts is expected to win the low barrier event. Harry Lamport ran the 220-yard hurdles in the Southern California track meet in 25:4-5s. Lamport is expected to run his race in 25:3-5s, or better on the fast Fresno track. The best time made in the north this year in the low hurdles is 26 seconds flat.

### SOUTH ON FIELD.

Although the central section has the best in the races, the south is expected to more than make up the difference when it comes to the field events. In these the central and northern sections are exceptionally weak this year. In the south the order of events is just reversed.

In the high jump the best made in the north has not been over 5ft. 10in. In the south Bidwell of Glendale, Thompson of Long Beach, Webster of Santa Paula and Stewart of Manual are all good for around 5ft. Bidwell and Thompson both cleared 5ft. 1 1/2 in. last Saturday.

Again, in the pole vault the south is expected to win heavily. Maurer of Manual Arts looks to be a sure winner in this event, with Hall and Webster of Santa Paula and Crowell all fighting for honors. All of these boys have cleared 11ft. 5in. or better. Maurer has a mark of 11ft. 8in. In the Central California championship meet the pole vault was won at 10ft. 6in. This mark will also win any meet around the bay cities.

### BRUBAKER.

Visalia won the shotput in the Central California meet at 42ft. This mark will not place in the State meet, for the south has shot putters far superior to that. Brubaker of Hemet, with a mark of 45ft. 11 1/2 in., and George Blewett of Manual Arts, with a record of 45ft. 8in., are both superior to anything in the north.

Don Stewart of Manual Arts and Thompson of Long Beach are both good for places in the discus throw. Both of these boys have thrown the discus from 110 to 115ft. The best made in the north so far has not exceeded 107ft.

# WINNERS OF VALLEY TRACK MEET UNDECIDED

Two Ties Must Be Run  
to Determine Visalia  
Or Bakersfield

Kern County May Lose  
Points Won in  
Relay Race

The first annual track and field meet of the central section of the California Interscholastic Federation was held at the fair grounds yesterday. First and second places between Bakersfield and Visalia are yet in doubt and will not be decided until the state meet here in April, when two ties materially affecting these two schools will be run off.

A meeting of the athletic committee in charge of the meet called to decide certain points at issue adjourned at midnight to meet again today.

The question taken up last night by the committee and which will be threshed out today is whether or not Bakersfield is entitled to three points for winning third place in the relay. It was stated in the meeting that Bakersfield had not entered a relay team. This was not discovered, as the relay was the only event in which the clerk of the course did not check the starters.

A tie for first and second in the 100 yard dash between Jennings of Coalinga and P. Lucas of Visalia and a tie between Veon of Bakersfield and Hayes of Visalia for third and fourth place in the 220 yard run must be decided at the state meet. This ruling was made by Referee James representing the A. A. U.

With Bakersfield losing three points by the relay, which brings it down to 46 points, and Visalia taking first place from Coalinga, Visalia has a chance of winning the meet in the dividing of the tied events.

F. Walters was awarded the individual trophy for scoring the highest number of points. He took three firsts, scoring 15 points.

## LAMPORT MAKES PREP RECORD.

H. Lamport, carrying the colors of the Manual Arts School of Los Angeles, clipped four-fifths of a second from the world's high school record in the 220-yard low hurdles here today in the first annual track and field meet of the California Inter-scholastic Federation of High Schools.

Lamport's time was 24 2-5s. R. Thompson of San Jose High School was second. Beckes of Bakersfield High School was disqualified this afternoon because he had participated in high school athletics for more than four years.

R. Thompson, San Jose, won the 120-yard high hurdles. His time was 15 3-5s.

## HOUSE IS STAR OF TRACK MEET.

### MANUAL ARTS WINS TROPHY-- SOUTHERNERS OUTPOINT NORTHERN RIVALS.

FRESNO, April 3.—The first interscholastic track and field meet held under the management of the California Interscholastic Federation was held here today.

The Southern California representatives easily proved their supremacy over the entire field from the balance of the State, as the final score will indicate.

Southern California 82 points.

Central California 33 points.

North Coast 22 points.

Northern California 6 points.

The seven sterling athletes competing under the colors of Manual Arts won the trophy for annexing the largest number of points, scoring the large total of 25 points, with Visalia High second with 18 points.

The balance of the schools finished as follows: Santa Paula 10 points; San Jose High 8 points; Los Angeles Poly High 7 points; Coalinga High 7; Exeter High 6; Sacramento High 6; Pasadena High 5; Santa Ana High 5; Hemet High 3; Glendale High 2; Bakersfield High 2; Palo Alto 1.

Four Coast and two world's interscholastic records were made that will probably stand for many years.

House, the largest individual point winner in today's meet, was the hero, whose name will go down in history as one of the greatest athletes California has ever produced.
