- 1. Roll Call. All schools represented.
- 2. Minutes of October 22, 1979, were accepted.

- 4. Agenda Additions:
  - 8.3 Menlo's need to schedule Girls' Sports.
- 5. Communications:
  - 8.1 Wayne Taylor questions and comments regarding assignment of baseball officials and fees.
- 6. Reports:
  - 6.1 Women Coaches Executive Committee.
    - 6.11 Volleyball coaches request establishment of a definite list of assignments.
    - 6.12 Basketball coaches wish to evaluate officials. Note: Chairperson may request a meeting with assignors.
  - 6.2 Men Coaches Executive Committee.
    - 6.21 M/S/C to table proposal for football schedule. Suggested: restudy. (Note: the round robin has been established by action of Sequoia District Sports Committee.)
    - 6.22 Menlo School may attend all of Sequoia's meets, thus making these contests triangular affairs. If Menlo's track facilities are improved to specification before the season, meets may be held at the Menlo track.
    - 6.23 M/S/C that SPAL track finals be held on May 10 or May 17 depending on the availability of a good facility.
    - 6.24 Proposal that two team champions--Dual Meet Champion and League Meet Champion--be named was returned to coaches for study.

- 6.25 Baseball M/S/C to allow a "soft toss" or "screen drill" before games. Battery practice is banned at that time.
- 6.3 C.C.S. Reports (Ferry).
  - 6.31 Track events must be supervised by a credentialled staff member.
  - 6.32 The 2-mile start will be arranged in such a way as to avoid congestion at the first turn.
  - 6.37 Law requires that the C.I.F. Board shall include at least one woman.

### 7. Unfinished Business.

- 7.1 Realignment Meeting Report.
  - 7.11 The result of the realignment meeting of December 12, 1979, is that all proposals are "frozen."
  - 7.12 Sunnyvale does not want to join SPAL.
  - 7.13 Realignment may take place only by mutual consent of schools and leagues.
  - 7.14 M/S/C that the Board's position at this time opposes any change in the SPAL.

## 8. New Business:

- 8.1 Officials' Fees (1980-81).
  - 8.11 Pat Balosky review and provide fee data sheets. She will negotiate with Wayne Taylor on baseball official fees.
  - 8.12 M/S/C that track starter-referee fee be raised from \$25.00 to \$30.00.
- 8.2 Basketball Shaughnessy Tournament 1980.
  - 8.21 M/S/C Playoffs will be limited to varsity Boys' and Girls' teams, games to be played on SPAL courts, host being school with highest round robin record.
  - 8.22 M/S/C the playoffs will be officially designated as the "Jimmy Coffis Playoffs."
- 8.3 Menlo School Girls' Sports.
  - 8.31 M/S/C Menlo School is allowed to schedule other SPAL Softball teams on any current bye date.
  - 8.32 M/S/C Menlo School may enter 1980-81 schedules for girls varsity and jay-vee tennis, soccer, softball and cross country.
