3) By-Laws Update

- a) By-Laws Status current version: May 24, 2018
- b) Article II # of contest changed to 14 by the State and CCS. Note change on league schedule.
- c) Article III, Section 2.8.1 added to clarify the # of events a pole vaulter can do in the Division meets: they can do 4 events, if they qualify in 4 for SCVAL, they must drop 1 to do the PV.
- d) Article IV, Section 3.1 and 3.1.2: 12 participants from each school per classification can compete in the 400m and down. For auto timing, winners can come from first 2 heats for tri and quad meets. (by-laws need to be clarified with: For Tri and Quad league meets, ...)
- e) Article III, Section 7 mutual agreement of coaches can decide dual meet entries and heats.
- f) Article V, Section 14 added to show future meet host for leagues, the order considers the host school for SCVAL.
- g) Article VI, Section 6 field events start at 4:30pm for SCVAL meet, running events time doesn't change.
- h) Article VII, order of events: the short hurdle order changes: VG, JVG, VB, FSB. Also, open pit for horizontal jumps may be used.

- g) T-shirts available at least 5 days before Semifinals, patches/pins can be bought anytime, other souvenirs at meet, will take credit cards at meet.
- h) Field events officials should arrive at least 30 minutes before the schedule start for warm ups, officials must be present for safety during warm ups
- i) The GPV will go first as will the VG LJ. The VG HJ will be in the second group of field events.
- j) Job Assignments for CCS Semifinals and Finals: Schools should provide a coach or knowledgeable adult for their shift. They must stay until shift is over and the next worker shows up.

High Jump (2-3 workers) Los Gatos

Head Official: SC – Boys, LG - Girls

Workers should arrive ready to work 45 minutes before the start of the event. Flags and paperwork will be provided for turn judges. HJ official should bring measuring tape and pencils. A \$100 fine or loss of entry for next year's meet could be levied if a league does not provide personnel for their events on time.

- k) CCS Evaluation Meeting Wed., May 28 at 4pm if needed.
- 1) Coach accompanying athletes (CIF rule)
- m) MBL and MTAL are combining leagues, they are now PCAL.
- n) Sanctioned Meets should have Implement Certification, Wind gauges. The same for big meets such as the League meets and SCVAL Championship Meet. Entries for Mt. Sac and Arcadia must be achieved at meets with wind gauges and implement certification.

Filios' email:

- o) All scrimmages must be held before the first league dual meet, otherwise it counts as 1 of your contests.
- p) Playoff policy 50 % rule: Each league contest (whether it be a dual meet, double dual, triple dual, tri-meet, etc.) counts as one (1) toward the 50% rule. The CCS Commissioner also confirmed that the league championship meet counts (trials and finals are not separate meets however) toward the 50% participation. See Steve Filios' handout for more information. If an athlete does not meet the 50% participation due to injury or grades, they may apply for a waiver from the League Commissioner.
- q) Mark McConnell is out of town for the league meets.
- r) AP test conflict for CCS Finals: Computer Science A noon test time. Athletes may ask for late testing which includes a \$45 fee.
- s) 800m start change for CCS: Commissioner Morgan acknowledged the concern of the Track and Field Committee and has placed a CCS Staff proposal on the agenda of both the CCS Executive Committee and the CCS Board of Managers: a proposal to amend the CCS Track & Field Bylaws to be implemented immediately which would require Meet Management to use "lane" starts in the 800 meters.

7) NFHS Rule Changes

- a) Every coach should have a copy of NFHS Track Rules Book, provided by the league. It is also a good idea to have a copy of NFHS Track Officiating Book and a Case Book. The are \$10.00 each, they are also available for kindle on Amazon -\$6.99 each.
- b) Please review the CCS handout for rule changes. There are minor changes and the uniform rule has been loosened.
- 8) a) 2019-2020 CIF Calendar is changing by 6 days due to Thanksgiving, State meet will be on May 29 & 30, so CCS Trials & Finals are May 16, 22.
 - b) Feb. 3 is the start date and May 9, 2020 is the last SCVAL event.

9) Post Season Meeting is May 13 at 6pm at Santa Clara High School in the administration building conference room.

10) Other

- a) Andy Anderson Relays will be held on Tues., Feb. 14, 3pm. Participating schools are Santa Clara (RE), Wilcox (SP), Lynbrook (HJ), Cupertino (TJ), Fremont (LJ) and Homestead (Discus).
- b) Time schedule Set by the By-laws Division Trials and Finals – Field – 3pm, Running – 3:30pm
- c) First alternates for sprints & hurdles should be at the League finals in case of a scratch.
- d) Field events- Officials: should be experienced. Per CCS: no warming up at field events until the officials are in place and opens up the event for warm ups. Official needs to stay vigilante during warm ups and competition and keep competitors and spectators safe.
- e) Dual meets prior to meet day, coaches should discuss any changes in meet set up: field event order, etc. Both coaches should agree with changes. Change of start time requires a Change of Schedule form.
- f) Timing Dual Meets: Hank Lawson would like the long jump to go first and be turned in by the start of the 800m. If open pits are used for by both jumps, he may only input the top 3 for long and triple jumps for scoring purposes and enter the rest of the marks when he gets home.

11) A few reminders for future meet directors:

- a) All job assignments should be filled, preferable with experienced workers, especially for the throws. There should be a starting line clerk if there is only 1 starter assigned to the meet. The starting line clerk will assist the starter with insuring the athletes are in the appropriate lanes and give last minute race instructions.
- b) Turn Judges should be assigned for the whole meet.
- c) There should be a Field Result Checker to verify the results and make sure that they are entered correctly into the computer.
- d) The Field Event Officials need to review the rules for checking out of an event and competing out of order. Athletes should only compete out of order if they have a conflict with another event.
- e) For tracks with no curb, cones should be placed on the inner edge of the track. It is best to have as many cones as possible. Check NFHS rules for distance between cones.
- f) Check for uniform violations at both running and field events.
- g) Discus is measured to the lesser inch.
- h) Meet Director should only direct the meet.
- i) All coaches need to help with meet management; unfortunately, we can't just coach our athletes.
- j) Starters have been requested from the scheduler Mark Greenough for Division Meets and SCVAL: 2 starters for SCVAL and Finals, 1 for the trials.
- k) Hank Lawson is timing Leagues, SCVAL keep him in the loop.
- 1) Wind gauges should be used, implements weighed and checked.


